To Kill Fleas: Before spraying, test a corner of fabric for compatibility. Hold container tilted down away from your face and with a sweeping side-to-side motion spray carpets, rugs, dog and cat bedding and under furniture. Fleas contacted with the spray will be killed.[One 15 oz. container treats 200 sq. ft.] [One 12 oz. container treats 160 sq. ft.]{or other appropriate conversion based on container size}
