DIRECTIONS FOR USE

Roaches, Ants, Waterbugs, Silverfish, Spiders, Crickets: Spray heavily in all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, etc. Use on other localized areas intested with these pests. Repeat treatment as required.

Carpet Beetles: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelvings. Repeat as necessary. Spot treatments of infested areas of carpets should be made.

Brown Dog Ticks: Thoroughly spray infested area around baseboards, window and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floors and floor coverings. Applications should be repeated as infestations warrant and as re-infestations occur. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

Flies, Mosquitoes, Wasps, and Flying Moths Outdoors: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames, or whenever these insects enter the room. Also treat surfaces around light fixtures on porches, in garages, and in other places where these insects alight or congregate.

Fleas, Chiggers, Ants, and Brown Dog Ticks Outdoors: For treatment of localized infestations of these insects in outdoor areas where there is no vegetation, spray infested areas thoroughly. For ants thoroughly wet hills and runways. Repeat applications as infestations warrant and as re-infestations occur.
