Total 100.0% E.P.A. Reg. No. 2568-45 FAF has been formulated using modern resins, selected for maximum adhesion to fibreglass. However, it will give completely satisfactory results when used on wood, properly primed metal or over most types of a previous season's anti-fouling paint that is in good condition.

### DIRECTIONS

Stir thoroughly both before and during application. Apply at least two coats—three on bare wood—allowing 4 to 6 hours drying time between coats and between final coat and launch. It is not advisable to delay launch more than 3 days after final coat. Apply by brush, roller, or spray gun. Ordinarily thinning is not necessary, but where it is desired, add not more than 10% REGATTA #3800 Thinner.

## SURFACE PREPARATION

Fibreglass. Sand the bottom thoroughly, using medium grit (about #100) paper. Wipe down carefully with REGATTA 3830 Fibreglass Solvent Wash. Use generous quantities of Solvent Wash and clean rags in order to remove the wax-like substance from the fibreglass gel-coat.

An alternate method of surface preparation is to use REGATTA 3840 Fibreglass Pre-Prime Wash and 3351 Fibreglass No-Sand Primer according to directions, thereby avoiding the necessity of sanding.

Wood. Apply three coats of FAF directly to bare wood.

Metal. Apply one coat of REGATTA Vinyltex 50/51 Wash Primer followed by two coats of REGATTA 3630/3631 Epoxydur Black Mastic.

Previously Coated Surfaces. Sand thoroughly, then wipe down with #3800 Thinner or 3802 Xylol Solvent.
