The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Pyrethrins, Piperonyl Butoxide, and MGK 264 REDs, and has concluded that your submission is acceptable.

NOTE: This product is <u>not</u> being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time. Furthermore, any required mitigation language for pet spot-on products must be addressed in a separate amendment.
