The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped “Notification” and will be placed in our records.

The alternate brand names “*Hartz UltraGuard Dual Synergized Botanical Pyrethrins Flea & Tick Shampoo for Dogs (& Puppies)*” and “*Hartz UltraGuard Dual Synergized Botanical Extract Flea & Tick Shampoo for Dogs (& Puppies)*” have been added to the product record.

1. Wet pet's coat thoroughly with water and rub shampoo into coat starting with head
2. Keep out of pet's eyes
3. Work backward from head to tail until coat is completely covered with foamy lather
4. Let stand or continue to massage in for 5 minutes
5. Rinse and towel dry
6. Repeat weekly (if necessary).

Do not use on (puppies) less than 12 weeks old. Consult a veterinarian before using this product on debilitated, aged, pregnant, nursing or medicated animals. Sensitivity may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your

pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.
