REMOVE COLLAR FROM PACKAGE, UNROLL AND STRETCH TO ACTIVATE. REMOVE PAPER COVER FROM REFLECTING STRIP.

The "2 in 1 Plus"." Reflecting Flea and Tick Collar provides an added dimension of night-time safety for the pet and his owner. The collar will reflect when light shines directly on the reflecting strip. To demonstrate this effect, sit in your parked car with the headlights on and have someone walk the dog into the headlight beam. The reflecting strip on collar will shine bright white from car or truck headlights, making the pet visible to the driver for up to 450 feet.

The Hartz "2 in 1 Plus " Reflecting collar kills fleas and ticks common to dogs, including Rocky Mountain Wood Tick, carrier of Rocky Mountain Spotted Fever. The collar will begin to kill fleas and ticks immediately. Its full protection against harder to kill ticks will be built up within a few days after being placed on the pet. For continuous flea and tick protection under normal conditions replace the collar every five months. Under conditions where dogs are exposed to severe flea or tick infestations it may be necessary to replace the collar more frequently. Wetting will not impair the collar's effectiveness or the pet's protection. If the dog goes swimming or is out in the rain it is not necessary to remove the collar. The Hartz "2 in 1 Plus " Reflecting collar may be worn with a regular collar.

Do not unroll collar until ready to use. Then unroll, stretch and remove paper cover from reflecting strip. Place the Hartz 2 in 1 Plus Meflecting collar around the dog's neck, adjust for proper fit and buckle in place. Be sure that the reflecting strip is on the outside of the collar. The collar must be worn loosely to allow for growth of the dog and to permit the collar to move about the neck. Generally, a properly fitted collar is one that when fastened will snugly slide over the dog's head. Leave 2 or 3 inches on the collar for extra adjustment and cut off and dispose of the extra length. Some animals may become unitated by any collar if it is applied too tightly. If this occurs loosen the collar, if initiation continues, remove the collar from the animal. This collar is intended for use only as an insecticide generator.

DISPOSAL - Do not use empty pouch. Dispose in trash collection.
