Dear Mr. Rosenwasser:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable with the following provision(s):

General Statement:

Delete all text throughout the label marked with "strikethrough."

<u>Precautionary</u> Statements section, Hazards to Humans and Domestic Animals subsection comment(s):

2. Replace the 5<sup>th</sup> sentence in paragraph #1 with: "Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet."

First Aid Statement section, Note to Physicians and Veterinarians subsection comment(s):

- It is important to note that the "1-800-275-1414" phone number should be available twenty-four (24) hours per day, seven (7) days per week for answering and responding to any medical emergencies or health concerns.
- 4. In the "Note to Physicians and Veterinarians:" subsection, replace the 1<sup>st</sup> sentence with: "This product contains tetrachlorvinphos (an organophosphate), which is a cholinesterase inhibitor."

Storage and Disposal Statement section comment(s):

5. To facilitate inclusion of language from PR Notice 2007-1, you should replace this section with:
