### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

### REMOVE COLLAR FROM PACKAGE, UNROLL AND STRETCH TO ACTIVATE INSECTICIDE GENERATOR

Do not unroll collar until ready to use. Place the Hartz "2 in 1" Plus collar around the dog's neck, adjust for proper fit, and buckle in place. The collar must be worn loosely to allow for growth of the dog and to permit the collar to move about the neck. Generally, a properly fitted collar is one that when fastened will snugly slide over the dog's head. Leave 2 or 3 inches on the collar for extra adjustment and cut off and dispose of the extra length. Some animals may become irritated by any collar if it is applied too tightly. If this occurs loosen the collar. If irritation continues, remove the collar from the animal. This collar is intended for use only as an insecticide generator.

Kills fleas and ticks common to dogs, including the Deer Tick, which may carry Lyme Disease, and the Rocky Mountain Wood Tick, which may carry Rocky Mountain Spotted Fever. The collar will begin to kill fleas and ticks immediately. Its full protection against harder to kill ticks will be built up within a few days after being placed on the pet. For continuous flea protection under normal conditions, replace the collar every seven months. The collar kills ticks for 5 months and aids in their control an additional 2 months. Under conditions where dogs are exposed to severe flea and tick infestations it may be necessary to replace the collar more frequently or augment its activity with another product registered for this use, such as Hartz 2 in 1 Flea and Tick Powder or Spray. Wetting will not impair the collar's effectiveness or the pet's protection. If the dog goes swimming or is out in the rain it is not necessary to remove the collar. The Hartz "2 in 1 Plus" collar may be worn with a regular collar. It is recommended that the pet's bedding or sleeping quarters be treated for flea and tick control with a product registered for this use such as Hartz 2 in 1 Flea and Tick Spray. It is not advisable to use this or similar pesticides on puppies less than six weeks old.

**DISPOSAL:** Do not reuse empty pouch. Dispose in trash collection.
