It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

For control of fleas, lice, and ticks on dogs and cats, dilute 4 ounces of Hartz® 2 in 1 Flea & Tick Dip with 1 gallon of water. Dip animal into solution, making sure hair is thoroughly wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Do not rinse. Towel dry. Repeat weekly (if necessary) for control. Consult a veterinarian before using this product of debilitated, aged, pregnant or nursing or medicated animals. Sensitivity may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

STORAGE AND DISPOSAL: Store in a cool place, away from heat or open flame. Do not reuse empty container. Wrap container and put in trash collection.
