2. Apply lightly and rub into animals coat. For long haired dogs, ruffle hair for spray to reach skin.
3. After 10 minutes, dry dog with towel.
4. Comb and brush coat.
5. Repeat once a week for fresh, glossy coat. Use on bedding and other areas as needed.
6. Kills fleas in 5 to 10 minutes. Ticks are tough - spray directly.
