1. Shake well. Remove overcap.
2. Hold can upright about 10 to 12 inches from pet. Point nozzle toward pet and press button. Do not hold tip of finger in front of nozzle. Move can to get even coverage of coat (until tips of hair are moist).
3. Apply lightly and rub into animal's coat. For long haired dogs, ruffle hair for spray to reach skin.
4. After 10 minutes, dry dog with towel.
5. Comb and brush coat.
6. Repeat once a week for fresh, glossy coat. Use on bedding and surrounding areas as needed.
7. Kills fleas in 5 to 10 minutes. Ticks are tough - spray directly.

### **STORAGE AND DISPOSAL**

**STORAGE:** Store in an area inaccessible to children.

**DISPOSAL:** Do not re-use empty container. Wrap in several layers of newspaper and discard in trash.
