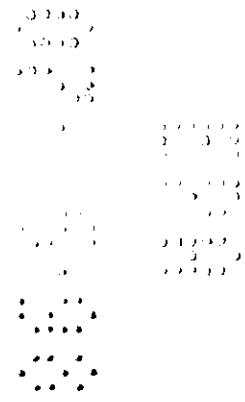

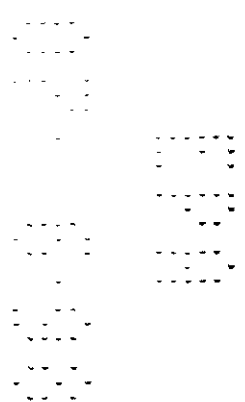

3. After 10 minutes, dry cat with towel.
4. Comb and brush coat.
5. Repeat once a week if necessary. Use on bedding and other areas as needed.
6. Kills fleas in 5 to 10 minutes. Ticks are tough - spray directly.

Storage and Disposal: Do not re-use empty container. Wrap container and put in trash collection.
