

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Shake well before using. To kill fleas, ticks and lice, point nozzle one inch from animal and press nozzle to release puffs of lather. Beginning at head and working toward the dog's hind quarters, rub the foam into the animal's coat. Treat face area by applying foam to fingertips and rubbing over face. After a few minutes, dry animal with a towel. Comb and brush animal for a clean lustrous coat. Repeat once a week if necessary. Kills fleas in 5 to 10 minutes. Ticks are tough - apply foam directly onto tick.

Storage and Disposal: Do not contaminate water, food or feed by storage or disposal. Wrap empty container and put in trash collection.
