To repel fleas and ticks, thereby reducing incidence of itching and scratching, hold container 6 to 10 inches from animal and spray over entire body, including feet and tail. Do not spray in eyes. For best penetration of spray to the skin, direct spray against the natural lay of the fur to cause fluff-

ing of the coat. In periods of heavy infestations, occasional fleas or ticks may be seen on the animal. For added protection, the animal's bedding, quarters and surrounding area should also be sprayed lightly until damp to help prevent reinfestation. For continuous control use the Hartz 2 In 1 Collar on your pet in addition to use of this spray. Do not expose your dog to other insecticides when using this product. Highly sensitive animals may occasionally experience some discomfort from any pesticide. If this occurs, discontinue use.

STORAGE AND DISPOSAL—Wrap empty container and put in trash.
