- b. The phrase "Causes moderate eye irritation" is consistent with products classified as Category III for eye irritation. Therefore Precautionary Statements should read:

- c. Delete "for fresh glossy coat." We are unaware of any ingredients in your formula to substantiate such a claim.
- d. According to our records the nominal concentration of Dupont's Technical Rabon is 98.8% pure. You should make the appropriate changes to your label and Confidential Statement of Formula.

4. Your acute dermal study is graded as core guideline and is placed in Category IV. Additional label revisions may be necessary upon submittance of an acceptable acute inhalation study.

5. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

2. Apply lightly and rub into animal's coat. For long  
haired cats, ruffle hair for spray to reach skin.
3. After 10 minutes, dry cat with towel.
4. Comb and brush coat.
5. Repeat once a week for fresh glossy coat. Use on  
bedding and other areas as needed.
6. Kills fleas in 5 to 10 minutes. Ticks are tough- spray  
directly.

Do not reuse empty container. Wrap container and put in  
trash collection. Do not contaminate water, food or feed  
by storage and disposal.
