#### SHAKE WELL BEFORE USING

- 1. Hold bottle upright 6 inches from pet. Direct spray toward pet and spray entire coat, pressing dispenser with quick short strokes. Move bottle to get even coverage of coat (until tips of hair are moist). 2. Apply lightly and rub into coat, ruffle hair for spray to reach skin.
- 3. Ticks are tough spray directly. 4. After 10 minutes, dry cat with towel. 5. Comb and brush coat. 6. Repeat once a week.

**Storage and Disposal:** Do not re-use empty container. Wrap container and put in trash collection. Do not contaminate water, food or feed by storage and disposal.
