1. On page one of your product labeling add the "statement"
FOR INSECTICIDAL USE ONLY.
2. On page two under the sub-heading, "keep children and pets out of room. Revise the statement to read: leave on for two hours, then vacuum. To read: leave on for two hours, thoroughly vacuum to remove all insecticide product. In addition, add the following statement: 6. Do not reapply this product within 30 days.
3. On page three revise the sub-heading, OPTIONAL/ALTERNATE LABEL TEXT TO read; ALTERNATE LABEL TEXT. This is required language text.

4. Leave on for two hours, then vacuum.
5. Remove vacuum bag after use and discard in trash.
