SHAKE WELL BEFORE USE

1. Hold bottle upright 6 inches from pet. Direct spray towards pet and spray entire coat pressing dispenser with quick short strokes. Move bottle to get even coverage of coat (until tips of hair are moist). 2. Apply lightly and rub into animal's coat. For long haired cats, ruffle hair for spray to reach skin. 3. Ticks are tough - spray directly. 4. After 10 minutes, dry coat with towel. 5. Comb and brush coat. 6. Repeat once a week.

Storage and Disposal: Do not re-use empty container. Wrap container trash collection. Do not contaminate water, food or feed by storage and disposal.

CAUTION: Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash hands and exposed skin thoroughly with soap and water after handling.
