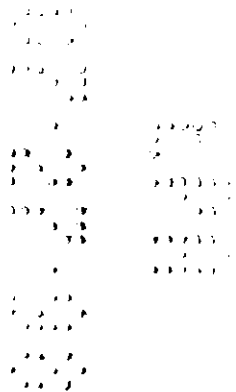

Point tip (of ampule) up and away from your face. Squeeze the middle of the tube to break the ampule. Position the tip of the tube (Press the tip of the tube) on the dog's back between the shoulder blades and squeeze tube to apply entire contents of the ampule (1cc) to the animal (.....to push the entire contents of the ampule (1 cc) through tip of the tube onto the animal).

(Note: this statement to be used on 2 cc package)

FOR LARGE DOGS (30 lbs and larger): (This product is packaged in single dosage ampules. One ampule (2 cc) is the correct dosage for a large dog.) (This product contains an ampule (2 cc inside a vial.) Point (the tip of the entire vial up) tip up and away from your face. Squeeze the middle of the tube to break the ampule. Position the tip of the tube (Press the tip of the tube) on the dog's back between the shoulder blades and squeeze the tube to apply the contents from the ampule to the dog until the contents level reaches the 1/2 mark indicated on the tube.
