## Dear Ms. Dickson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Your use directions are only for dogs and puppies under or over 30 lbs .

Therefore, delete all other statements that refer to weights other than "under 30 lbs" or "over 30 lbs ." Refer to comment 3 in our letter of June 22, 1999.
2. Delete the alternate brand names listed on the front panel. These names have not been approved by the Agency. Alternate brand names must be approved by the Agency as per 40CFR 152.10 (b) (2) 9 (ii).
3. Add the following statement to the precautionary statements related to cats: "May be toxic and potentially fatal if applied to or ingested by cats".
4. Add "and other aquatic organisms" at the end of the sentence under Environmental Hazards.
5. On page 6 replace "Eliminating" with "Controlling".

Remove one applicator tube from the package and hold in an upright position (pointed away from your face). (Pull off cap. Turn the cap around and place on top of tube. Simply press cap down to break the seal of the tube. Remove cap carefully.) (Hold bottom of tube with one hand. With the other hand, snap cap off.)

Position the tip of the tube on the dog's back between the shoulder blades. Use the tip of the tube to part the dog's hair so that the product will be applied at skin level. Begin squeezing out the contents of the tube to form a stripe as you move from the shoulder blades along the dog's back to the base of the tail. (Repeat every month.) [Repeat (reapply) every 30 days if necessary.]

Directions Option 2 (for use on packages intended for dogs 15 lbs. and under, 16-30 lbs., and up to 30 lbs):
(The application steps below may optionally be numbered or bulleted to clarify the order, depending on the final physical layout of the label)
(This product is packaged in single dosage ampules. One ampule ( 1 cc ) is the correct dosage for a small dog.) (This product contains an ampule inside a vial.) Point tip (of ampule) up and away from your face. Squeeze the middle of the tube to break the ampule. Position (Press) the tip of the tube on the dog's back between the shoulder blades and squeeze tube (to apply entire contents of the ampule ( 1 cc ) to the animal) (to push the entire contents of the ampule ( 1 cc ) through tip of the tube onto the animal).
