REMOVE COLLAR FROM PACKAGE, UNROLL AND STRETCH TO ACTIVATE INSECTICIDE GENERATOR. AS THE COLLAR BEGINS TO WORK., A FINE WHITE POWDER WILL APPEAR ON THE SURFACE.

Do not use on puppies under 6 weeks old (kittens under 12 weeks old). Do not unroll collar until ready to use. Place the Hartz® Rabon Collar with Methoprene around the dog's or puppy's (cat's or kitten's) neck, adjust for proper fit, and buckle in place. The collar must be worn loosely to allow for growth of the animal and to permit the collar to move around the neck. A properly fitted collar is one that, when fastened, will snugly slide over the pet's head. Leave 2 or 3 inches on the collar for extra adjustment and cut off and dispose of the extra length.

Its full protection against harder-to-kill ticks will be built up within a few days after being placed on the pet. For continuous protection under normal conditions replace the collar every 7 months. Under conditions where pets are exposed to severe flea and tick infestations it may be necessary to replace the collar more frequently. Wetting will not impair the collar's effectiveness or the pet's protection. If the pet goes swimming or is out in the rain it is not necessary to remove the collar.
