- 3) Move the phrase "SEE BACK PANEL..." to a position below the signal word "CAUTION" on the front panel of the label.
- The product name we have on file for your product is "Hartz Rabon Spray w/Methoprene Formulation Pump". This differs from your labeled product name of "Hartz Rabon Spray with Methoprene Pump Formulation". Please verify the correct product name for our records.
- 5) Please add your company name and complete address to the front panel of the label.
- On the back panel, delete the word "powerful" in the statement "..a powerful, effective insecticide". Words or phrases implying that product possesses unique characteristics because of its composition are not acceptable.
- 7) Delete the statement "It is not advisable to use this product or similar products on puppies or kittens less than 6 weeks of age".
- 8) Under Optional Copy #2, change "eliminating" to controlling in the heading. Claims implying total eradication or elimination of pests are not acceptable.
- 9) Add the heading "Environmental Hazards" to your label directly below the "Physical and Chemical Hazards" section. Under this heading, the following statement must be added: "This product is toxic to aquatic invertebrates. Using it in a manner other than that described by the label could result in harm to aquatic invertebrates."
- 10) Move the statement "READ ENTIRE LABEL BEFORE EACH USE" to a position below the "DIRECTIONS FOR USE" section. Add the following statement "USE ONLY ON (DOGS,

### CATS or DOGS OR CATS)."

- 11) Either delete the phrase "Repeat as necessary" or specify a time period for repeat applications based on the residual efficacy of the product.
