SHAKE WELL BEFORE USE: To kill and repel fleas, ticks and lice (for 7 days) (for 1 week), (thereby reducing incidence of itching and scratching) and to kill flea eggs and prevent their hatching for 1 month (28 days) (4 weeks), hold container 6 to 10 inches from the animal and spray lightly over the entire body. Once sprayed, fleas will be killed within 5 to 10 minutes. Ticks are tough - spray directly. Do not spray in eyes. For best penetration of spray to the skin, direct spray against the natural lay of the hair to cause fluffing of the coat. In addition to controlling fleas and ticks, this product leaves your pet's coat soft, glossy and manageable.

Under normal circumstances, to kill (adult) fleas and ticks, repeat spray once every few days until infestation is brought under control, then repeat as necessary. For more prolonged flea and tick control, the animal's bedding, quarters and surrounding area should also be sprayed lightly until damp to help prevent reinfestation.

STORAGE AND DISPOSAL: Do not contaminate water, food or feed by storage and disposal. Wrap empty container and put in trash collection.
