The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

The net contents are required to be presented in US customary units of measure, (fluid ounces). The label may also present optional metric equivalent. The label in some places refers to cubic centimeters, and elsewhere to milliliters. To avoid confusion, use one or the other.

Confirm the fluid ounce net contents for dogs over 60 lbs. and correct if necessary.

The net contents on the individual tubes must be the net contents for each weight class. A range is not acceptable.

On the individual tube label, revise the reference to the complete label to read: Read accompanying label before use.

All references to "larvae" must read "flea larvae".

Delete the following claims, which are not supported by the data submitted: Starts working on contact.

Dual action for immediate and long lasting effects.

Delete the following comparative claims:

Powerful results when you need it. ...improved application.

Delete the following claims, which are false and misleading:

When your dog has fleas and ticks, your family and pet may be exposed to: fleas that may cause) flea allergy dermatitis, flea bite anemia, tapeworm infestation, deer ticks which may carry lyme disease, lyme disease, mosquitoes that may carry west nile virus, west nile virus.

Delete references to a website, as this reference makes the website collateral labeling, and the collateral labeling has not been reviewed.

Delete the following claims which imply 100% efficacy:

Claims using the terms "protect" and "protection".

Claims using the term "eliminates."

Claims to "provides relief from flea infestations" and "provides relief from flea and tick infestations (from flea and tick populations)."

Claims about "making your pet flea-free".

Revise the claim "For dogs and puppies four pounds or more" to read "For dogs and puppies over four pounds."

Delete the following safety claim: "Clean..."

To avoid misuse, all product names, including both the outer package as well as the individual tubes, must include the size dog/puppy for which the product is intended.

Acceptance of this label does not constitute approval of claims appearing on this label that are made for other Hartz products. Label claims for other Hartz products must be qualified by a statement referring the user to the labels for those products.

As noted in the Agency's letter of Dec. 14, 2006, the due data for data supporting mosquito claims is due Dec. 14, 2007. Copies of the efficacy and companion animal safety reviews are enclosed.

Changes in package size must be submitted as an amendment and not as a notification as they may affect both efficacy and margins of exposure for the treated dog.
