Position the tip of the tube on the dog's back between the shoulder blades. Use the tip of the tube to part the dog's hair so that the product will be applied at skin level. Begin squeezing out the contents of the tube to form a stripe as you move from the shoulder blades along the dog's back to the base of the tail.

FOR CATS

Position the tip of the tube at the base of the cat's head. Use the tip of the tube to part the cat's hair so that the product will be applied at skin level. Begin squeezing out the contents of the tube to form a spot at the base of the cat's head. Application to the base of the cat's head will reduce the opportunity for the cat to lick the product. Avoid contact with the cat's eyes and mouth.

Repeat every month.
