The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

The package for dogs 31 to 60 lbs with a dose of 0.09 fl. oz. is not approved. The dose for dogs 31 to 45 pounds must be packaged in 0.09 fl. cz. size tubes and the dose for dogs 46 to 60 pounds must be packaged in 0.14 fl. oz. size tubes. The label must reflect these package size changes.

Revise the packaging for the smallest weight classes as follows: For dogs and puppies weighing 4 to15 lbs (0.04 fl. oz) For dogs and puppies weighing 4 to 30 lbs. (0.04 fl. oz.)

Add to the label the following: Do not use on dogs or puppies weighing 4 lbs or less.

Within one year you must submit data (with the appropriate PRIA fee) to support mosquito claims or remove mosquito claims from the label.

Within one year you must submit data (with the appropriate PRIA fee) to support claims against the Rocky Mountain wood tick or remove these claims from the label.

Revise the Precautionary Statements to read as follows:

In accordance with the efficacy review, remove the following enhanced efficacy claims: Fast Acting Long Lasting

As set forth in the label review manual, the individual tubes must bear the following labeling: Product name, including the weight of dog for which the product is intended, ingredient statement, signal word, child hazard warning, EPA registration number, EPA establishment number, net contents, and a statement referring the user to the accompanying label. The product name must match the name on the exterior package.

The product names "Omni Force" and "Ultra Force," unless trademarked, are enhanced efficacy claims and must be deleted.

The "3 in 1" claim when not appearing as a trademarked product name must be qualified by an explanation. Otherwise it is an enhanced efficacy claims and must be deleted.

The claim "3 month protection" must be qualified to explain what pests it refers to and how you get this length of protection.

Add at the end of the First Aid statements the following: You may also contact 1-800 xxx-xxxx for emergency medical treatment information.

Delete claims that the product lasts works protects adult fleas and ticks.

Acceptance of this label does not constitute approval of claims appearing on this label that are made for other Hartz products. Such label claims must be qualified by a statement referring the user to the labels for those products.

All future changes in package size must be submitted as an amendment and not as a notification. A copy of the efficacy and companion animal safety reviews are enclosed. If you have questions, please call Ann Sibold at 703 305-6502.






