

- 1. Wet pet's coat thoroughly with water and rub shampoo into coat starting with head
- 2. Keep out of pet's eyes
- 3. Work backward from head to tail until coat is completely covered with foamy lather
- 4. Let stand or continue to massage in for 5 minutes
- 5. Rinse and towel dry
- 6. Repeat weekly (if necessary).
