Hartz UltraGuard Plus Flea & Tick Home Spray (alternate brand name) can be used in homes, garages, attics, apartments, and hotels to kill fleas and Brown Dog ticks. One bottle will treat a surface area up to [360] [500] square feet. A fine spray applied uniformly is all that is necessary to kill fleas. Avoid wetting furniture and carpeting. Remove birds and cover aquariums before spraying.

For maximum effectiveness treat entire carpeted area. Treat carpets, rugs, drapes and all surfaces of upholstered furniture. Pet bedding should be allowed to dry completely before pets return to their bedding area. Leave treated areas and do not return for least one hour. Retreat as necessary. Avoid contamination of food and food stuffs. To kill Brown Dog ticks in the environment, spray product directly on pests.

STORAGE AND DISPOSAL:


