

DIRECTIONS FOR USE

For most effective results, use a good sprayer adjusted to deliver a fine mist.

FOR FLYING INSECTS such as mosquitoes, flies, gnats: Close all doors and windows. Direct the spray to all parts of the room. Fill the room with mist, then leave the treated area. Keep room closed for at least 15-30 minutes. Ventilate the room when treatment is completed.

FOR CRAWLING INSECTS such as roaches, earwigs, grain mites, sowbugs, spiders and centipedes: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes, sinks and other points of entry, under refrigerators, baseboards and storage areas. Spray directly on insects where possible. Repeat as necessary.

WASPS: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

ANTS: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
