d. Revise the claim "Bacterial growth within this cartridge is inhibited" to read as follows:

"This product inhibits the growth of bacteria in the filter to prolong the life of the filter."

- e. The phrase, "Fine-Filters Asbestos", is not permitted and should be deleted from the product labeling.
- f. The statement "Cartridge should serve a family of four for one year when used with a separate faucet" must be more specific. It should give the number of gallons used per day. Revise the statement to read as follows:

"Cartridge should serve a family of four for one year when using four gallons per day."

- g. Delete the term "Municipally or non-community tap water treated" because it is misleading and should be removed according to the Safe Drinking Water Act and the National Interim Primary Drinking Water Regulations.

- m. Place the claim "Use with cold water only" on the product labeling as outlined in the product labeling requirements for the Silver RED.
- n. Delete the phrase "Premium Quality Water" from the product labeling. The phrase is considered misleading.
