- 3. Verify that the bulk density of Ocean Spray Insecticide is 8.32 lbs./gal. This figure seems unlikely, because the bulk density of the source product Clearmol Concentrate is listed as 8.56 lbs./gal. and the bulk density of water is 8.33 lbs./gal.
