DIR MOTIONS FOR CONTROL OF SPECIAL PESTS:


ROVERS, WAT ERBUGS: Treat all cracks and crevices using a coarse wet spray or paint brush. Use under sinks, drainboards, stoves, cabinets, drawers and around baseboards. Repeat as necessary.

ANTS: Paint or spray surface until damp, wherever ants travel. Treat areas around door sills and window frames, heat ducts and baseboards where ants may enter. Pour into ant hills. Repeat when necessary.

CARPET BEETLES: Paint or spray on fer and around edges of carpeting. Heart baseboards and shelves of closets. Repeat as necessary.

sta V REISH: Same as for roaches, but compassis should be given to treatment of base roards, areas behind shelving, bookcases and storage areas. Repeat as necessary.
