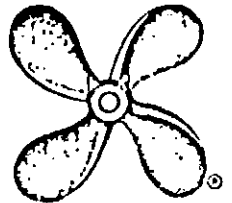

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER

KEEP OUT OF REACH OF CHILDREN

Corrosive. Causes eye irritation and skin burns. When handling wear full protective clothing, rubber gloves, goggles, face shield or other approved eye protection. May be fatal if swallowed or inhaled. Harmful if absorbed through skin. This product may be a dermal sensitizer. Avoid contact with skin, eyes or clothing. Remove and wash contaminated clothing before reuse. Avoid breathing vapor, spray mist, dust or chips from sanding or blasting. Wash thoroughly with soap and water after handling and before eating or smoking. Use with adequate ventilation.

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol. Get medical attention immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.

If on skin, wash with plenty of soap and water. Get medical attention. If in eyes, flush with water for at least 15 minutes. Get medical attention immediately. If inhaled, remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention immediately.

ENVIRONMENTAL HAZARDS: This material is toxic to fish. Do not apply directly to water by cleaning of equipment or disposal of wastes. Do not allow chips and dust generated during paint removal to enter water. Dispose of paint debris in an approved landfill.

PHYSICAL OR CHEMICAL HAZARDS: FLAMMABLE! Keep away from heat or open flame.

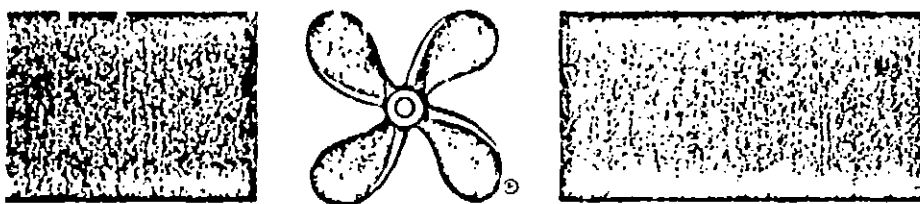

DIRECTIONS FOR USE
