

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER

KEEP OUT OF REACH OF CHILDREN

Corrosive. Causes eye irritation and skin burns. When handling wear full protective clothing, rubber gloves, goggles, face shield or other approved eye protection. May be fatal if swallowed or inhaled. Harmful if absorbed through skin. This product may be a dermal sensitizer. Avoid contact with skin, eyes or clothing. Remove and wash contaminated clothing before reuse. Avoid breathing vapor, spray mist, dust or chips from sanding or blasting. Wash thoroughly with soap and water after handling and before eating or smoking. Use with adequate ventilitien.

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg (whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol. Get medical attention immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.


