DIRECTIONS

When applying "SUPERTROP" ANTIFOULING PAINT, allow overnight drying time between coats and launch within 72 hours after application of final coat. Paint should be dry to touch before immersion. If this schedule is not possible, launching may be delayed for several days provided the composition is not subjected to the direct rays of the sun. Overhardening of the composition before launching will affect in a deleterious manner initial antifouling paint protection.

PREVIOUSLY PAINTED SURFACES --- If old finish is in good condition, "SUPERTROP" ANTIFOULING PAINT can usually be applied directly over it after a thorough sanding with medium grit paper. When in poor condition, remove old finish to bare surface and follow painting instructions as below.

BARE SURFACES — WOOD — Apply three coats to bare wood. No special primers are required.


FIBERGLASS — Sand surface thoroughly with 1/0, 80 Grit Production Paper. Apply one coat of 347 "INTERLUX" "PRIMOCON" SILVER followed by two c ats of "SUPER-TROP" ANTIFOULING PAINT.

STEEL - On steel vessels at least two coats of "SUPER-TROP'' ANTIFOULING PAINT should be applied over three priming coats of 347 "INTERLUX" "PRIMOCON" SILVER.
