Kernic may be used as an aid in the control of Brown Dog Ticks on dogs, cats, and premises and is effective against fleas on dogs and cats.

This product should not be applied by **children**. Use product only outside or in a well-ventilated area.

For control of ticks and fleas on dogs and cats: Wearing household latex or rubber gloves, dust entire animal, avoiding pet's eyes, nose, mouth, and genital areas. Rub or brush pet's hair to work dust down to the skin. Be sure to apply also to the feet, between the toes, and on the legs. Comb out dead ticks a few hours after treatment.

When dusting mother dogs or cats, remove the mother for treatment and return her to the puppies or kittens after one or two hours. Repeat every week if needed.

**In kennels, dog houses:** Dust in and around sleeping quarters and other areas where ticks and fleas occur. Dust bedding and doghouse using a shaker can or other dust applicator.
