DIRECTIONS FOR USE

DO NOT USE ON DAIRY ANIMALS OR IN DAIRY BARN

ON CATTLE AND HORSES: To control Horn Flies, Cattle Lice, Ear Ticks, Lone Star Ticks, Gulf Coast Ticks, Winter Ticks and Cattle Fever Ticks, mix 1 quart of LINTOX-D with 25 gallons of water and stir well to form a creamy emulsion. Treat animals with a strong spray to penetrate to the skin, or dip thoroughly. Hand dip young animals. Approximately two quarts of spray are required for adult animals and proportionately less for younger animals. Be sure not to over-dose young animals. For Ear Ticks and Gulf Coast Ticks, apply with low pressure to ears, head, neck and shoulder regions. For Tick control, repeat as necessary but not more often than once every two weeks. One spraying of LINTOX-D will control Horn Flies up to three weeks and a single treatment will often control Lice. Repeat as necessary, but not more often than every 2 weeks. Prior to dipping, water animals well to prevent drinking of vat fluid or runoff.

ON SHEEP AND GOATS: To control Sheep Lice, Goat Lice, Sheep Tick (Keds), and Wool Maggots, use 1 quart of LINTOX-D with 25 gallons of water, mix well and spray or dip animals thoroughly. When dipping animals, be sure to wet them thoroughly. Always stir dipping vat well just before using. Repeat as necessary, but not more often than every 2 weeks.

ON HOGS: To control Hog Lice use 1 quart of LINTOX-D to 25 gallons of water, mix well, and spray animals with a strong spray to thoroughly wet the skin. Repeat as necessary, but not more often than every 2 weeks. Do not treat sows within 2 weeks of farrowing or while nursing.

IN BACKRUBBERS: As an in the control of Horn Flies and Lice on beef cattle, dilute 1 quart of LINTOX-D with 9 quarts of fuel oil or other suitable carrier and charge backrubber device or soak sack or cloth as occasion requires. Retreat backrubber as needed. Do not spray animals with this solution. Do not "pour on" oil solutions.

AS A PREMISE SPRAY FOR KENNELS AND LAWNS: To control Fleas and Ticks in kennels, dog runs, lawns and outdoor areas, dilute 1 quart of LINTOX-D with 30 quarts of water. Thoroughly spray places where animals sleep and dog run areas. Apply 1 gallon of diluted mixture per 1000 sq. ft. for Fleas and Ticks on lawns. Do not treat livestock with this concentration. Do not treat pets or their

bedding with this product. Do not use for flea control in the home. Keep children and pets off treated areas until this material is washed into the soil and grass is dry. Repeat as necessary.

WARNING: Poisonous if swallowed, inhaled or absorbed through skin or eyes. Do not get in eyes or on skin. Do not breathe fumes or spray mist. Do not contaminate feed or foodstuffs. Wash hands, arms, and face thoroughly with soap and water before eating or smoking. Wash contaminated clothing before re-using. Do not treat animals under 3 months of age. Do not use or store near heat or open flame.

ANTIDOTE: If swallowed, give 1 tbs. salt in a glass of warm water, repeat until vomit fluid is clear. Have victim lie down and keep quiet. CALL A PHYSICIAN IMMEDIATELY. In case of skin contact, remove contaminated clothing and wash skin with soap and water. For eyes, flush with running water for at least 10 minutes and get medical attention. If inhaled, remove victim to fresh air. Atropine is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine.

Do not reuse empty container; bury or discard in a safe place. Destroy by crushing.

"This product is toxic to fish, birds, and other wildlife. Keep out of any body of water. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label."

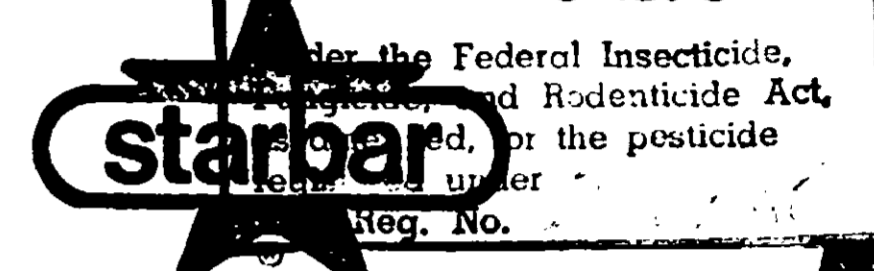
