

HORSE FLY SPRAY is especially designed to protect Horses, Ponies, and Show Stock from Stable flies, Horn flies, Horse flies, Deer flies, Face flies, House flies, Mosquitoes and Gnats.

## DIRECTIONS FOR USE

Remove protective cap. Hold container in an upright position with valve opening pointing toward animal to be treated. Press valve button to spray.

Apply HORSE FLY SPRAY so as to lightly dampen animal's hair. Spray animal thoroughly including legs and under belly. Repeat spray daily as needed.

#### FOR FACE FLIES

To protect animals from face flies, spray animal's head and neck, using just enough spray to slightly dampen the tips of hair. Repeat as needed.

HORSE FLY SPRAY container should be held 12 to 18 inches from animal when spraying. Do not apply in excess of 2 ounces of spray per animal per day (about 11/2-2 minutes of spraying time).

#### CAUTION

Do not store above 130° F. Never puncture container or throw into fire. Harmful if swallowed, inhaled or absorbed through skin. Avoid prolonged breathing of spray mist or contact with skin, eyes or clothing. Do not contaminate feed, water or food stuffs. Keep out of the reach of children. Wash thoroughly with soap and water after handling and before eating or smoking. If swallowed, induce vomiting immediately and get medical attention. Atropine is anticiotal.



### **Directions For Use**

Lewns – For control of <u>Ticks</u> and <u>Flees</u> in lawns and outdoor areas, dilute one pint of VET-KEM YARD SPRAY with 4 gallons (8 tablespoons per gallon) of water to make a 0.5% solution. Spray infested areas, paying particular attention to places where dogs have been sleeping or resting. One pint of VET-KEM YARD SPRAY will treat 4000 sq. ft. of lawn. Keep children and pets off wated areas until dry.

Vet-Kem Yard Spray may be applied in garden type hose proportioners by following the dilution given on the proportioner.

<u>Dog Houses</u> — To control <u>Ticks</u> and <u>Eleas</u> in dog houses and kennels, dilute 1 pint VET-KEM YARD SPRAY with 4 gallons of water and spray dog house and surrounding area thoroughly. Let material dry before releasing dogs in area.

Warning — Poisonous by skin contact, inhalation or swallowing. Do not get concentrate in eyes, on skin or on clothing. Do not breathe vapors or spray mist. Wash thoroughly with soap and water after handling concentrate. Do not contaminate feed or foodstuffs. Keep out of reach of children.


First Aid — If swallowed, induce vomiting. If on skin, remove contaminated clothing and immediately wash the skin with soap and water. Atropine is antidotal.
