Directions: Use at least one canister for each 6 000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. important: Fogger must be placed on table, chair or stand when releasing. Place newspapers under canister to prevent marring surface. Close doors and windows. Remove pets. Cover fish tanks or bowls with paper or remove. Cover exposed foods, dishes, and food handling equipment. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners. Put out all open flames except pilot light. Place at least 6 feet away from pilot light. Keep at arm's length when releasing. Point top of can away from face and eyes.

To start fogging, place plastic clip over edge of canister lip to start fogging action. Set in upright position and leave the building at once. Leave undisturbed for 2 hours. Open doors and windows and allow to air for 30 minutes.
