Thread flat end of the collar through buckle hole and tighten as necessary, so that at least two ridges are covered by the buckle. Collar must be worn loosely, but securely enough to prevent easy ridges. Cut off any excess length and discard in trash.

The expandable section molded into the collar will stretch under the weight of an average size cat and allow the cat to free it lif if it becomes hooked or entangled by the collar. Since both the expandable section and plastic buckle are molded into the collar, the prot bility of neck irritation and buckle failure is reduced.

To release the collar, squeeze buckle between thumb and finger and pull sharply.

Do not use on kittens under 6 weeks of age.

DIRECTIONS: Remove collar from package and place around cat's neck. Adjust for proper fit and buckle in place. Collar must be worn loosely but securely enough to prevent easy removal and loss. Cut off any excess length of collar, leaving ample tength for expansion as the cat grows, and dispose of by discarding in trash. Check and adjust collar periodically to assure a proper fit.

Do not use on kittens under 6 weeks of age.

RESULTS EXPECTED: The flea and tick collar starts killing fleas and ticks when it is placed around the cat's neck. Fleas will be killed and new ones which may temporanly appear on the cat will also be killed during the 5 months. Ticks are tough occasional pests of cats and will be killed within a 'ew days. For continuous protection, replace collar when effectiveness diminishes.
