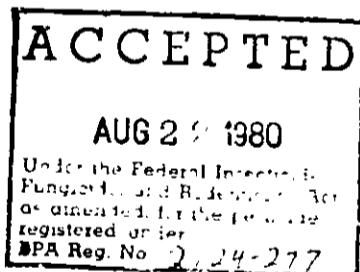


# ZOECON RF-50 DUST FOR DOGS

Controls Sarcoptic Mange on Dogs - Controls Fleas

**PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS — CAUTION:** Harmful if swallowed or inhaled. Avoid breathing dust. Avoid contact with eyes. Avoid unnecessary contact with skin or clothing. Wash thoroughly after using.

**STATEMENT OF PRACTICAL TREATMENT:** If swallowed - Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention immediately. If inhaled - Remove victim to fresh air and apply respiration if indicated. If in eyes - Flush with plenty of water. Get medical attention if irritation persists.

**NOTE TO PHYSICIAN:** This product contains an organophosphorous insecticide. Atropine is antidotal.

**DIRECTIONS FOR USE:** It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product is effective in controlling Sarcoptic Mange on dogs. It controls fleas on dogs for up to 21 days. Brown Dog Ticks and American Dog Ticks on dogs will be controlled for up to 14 days.

**FOR CONTROL OF SARCOPTIC MANGE ON DOGS:** Treat dog using 1/4 teaspoon (tsp.) (0.5g) of dust per pound of body weight weekly for 3 weeks. Treat entire dog paying particular attention to infected areas and rub thoroughly into hair to the skin. If no improvement is observed in 21 days, consult your veterinarian.

**FOR CONTROL OF TICKS AND FLEAS ON DOGS:** Apply dust liberally over the animal at the rate of 1/4 teaspoon (tsp.) (0.5g) per pound of body weight beginning at the head and rub thoroughly into hair to the skin. Be sure to treat the legs and feet. Minimize treatment of eyes and face. Do not treat puppies under 12 weeks of age.

**DISPOSAL:** Do not use empty container. Dispose in trash collection.
