Use of this flea growth regulator will prevent the normal life cycle of the flea, preventing the adult flea from developing. Flea eggs, larvae, and pupae will not develop into adult fleas. Fleas that are already present will not be able to reproduce.

If a flea infestation of your pet (the biting stage) is present, the use of an adulticide may be necessary for immediate relief. For best results, use ZOECON RF-174 flea growth regulator prior to the flea infestation.

When applied to carpets, where fleas are found, such as carpets, upholstered furniture and pet sleeping areas, ZOECON RF-174 flea Growth Regulator prevents adult fleas emergence for 3 months.

Flea control of pets is important in prevention of introduction of adult fleas indoors. When using this product, and fleas are breeding on pets, the pets should be treated with an effective registered flea control product to prevent the introduction of adult fleas indoors.

METHOD AND RATE OF APPLICATION: Prepare a diluted spray solution by adding 1/2 teaspoon (2.5 milliliters) of ZOECON RF-174 Flea Growth Regulator to 3 gallons of water. Partially fill the mixing container with water, add ZOECON RF-174 Flea Growth Regulator, shake, and fill to final volume. Use diluted spray solution within 24 hours of mixing. Shake before each use.

Apply at a rate of 1 gal. of diluted solution per 800-1000 sq.ft. of surface area with any low pressure sprayer typically used for indoor applications. Treat all areas which may harbor fleas, including carpets, furniture, pet sleeping areas and throw rugs. Treat under cushions of upholstered furniture. Avoid contact with treated surfaces until dry.

STORAGE & DISPOSAL Store in a cool place. Do not use empty container. Wrap container and put in trash collection.
