PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS - (CAUTION): harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of spray mist. Avoid contact with skin, eyes or clothing. Wash thoroughly after handling.

STATEMENT OF PRACTICAL TREATMENT: If swallowed - Call a physician or Poison Control Center immediately. Do not induce vomiting. Note to Physician: May present aspiration hazard. Atropine should be administered only if symptoms of cholinesterase inhibition appear. If inhaled - Remove victim to fresh air. Apply artificial respiration if indicated. If on skin - Remove contaminated clothing and wash affected areas with soap and water. If in eyes - Flush eyes with plenty of water. Call a physician immediately.

Avoid contamination of food and foodstuffs. Do not use in edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

PHYSICAL OR CHEMICAL HAZARDS: Contents under pressure. Do not use or store near heat or open flame. Exposure to temperature above 130°F may cause bursting. Do not puncture or incinerate.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use at least one canister for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where full flow of mist is not assured.

Remove pets. Cover fish tanks or bowls with paper or remove.

Important: Fogger must be placed on table, chair or stand when releasing. Place newspapers under canister to prevent marring surface. Close doors and windows. Cover exposed foods, dishes, and food handling equipment. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners. Put out all open flames except pilot light. Place at least 6 feet away from pilot light. Keep at arm's length when releasing. Point top of can away from face and eyes.

Press down actuator tab to lock in position to start fogging action. Set in upright position and leave building at once. Leave undisturbed for 2 hours. Open doors and windows and allow to air for 30 minutes before allowing the building to be reentered.

STORAGE & DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Do not use empty container. Wrap container and put in trash collection.
