One treatment gives continuous protection against pre-adult fleas for 4 months [120 days][17 weeks].

Zoecon RF-217 RTU Carpet Pump Spray kills fleas, ticks, roaches, ants, spiders, crickets, silverfish, earwigs, and pillbugs. It leaves no bad smell, no sticky mess and will not stain furnishings.

To protect your pet against fleas outdoors, use a (brand name) flea or flea and tick collar, (brand name) pet dust, (brand name) pet spray, (brand name) pet dip, or (brand name) pet shampoo.

**PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS - CAUTION:** Harmful if swallowed or absorbed through the skin. Avoid breathing spray. Avoid contact with skin, eyes, or clothing. Wash thoroughly after handling. Leave treated areas and do not return for at least one hour. Do not allow children or pets to walk on treated surfaces until they are completely dry. Do not spray on pets or humans. Avoid contamination of food and foodstuffs. Do not use in edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

**STATEMENT OF PRACTICAL TREATMENT:** If swallowed - Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching finger to back of throat. Never give anything by mouth to an unconscious or convulsing person. Note to Physician: Chlorpyrifos is a cholinesterase inhibitor. Atropine sulfate by injection is antidotal only if symptoms of cholinesterase inhibition are present. If on skin - Remove contaminated clothing and wash affected areas with soap and water. If in eyes - Flush eyes with plenty of water. If irritation persists call a physician.

**DIRECTIONS FOR USE** - It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Shake well before using.

**Fleas:** For maximum effectiveness treat entire carpeted area. Adjust spray nozzle to create a fine spray. Treat carpets, rugs, drapes and all surfaces of upholstered furniture. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet area. Retreat as necessary.

Use Zoecon RF-217 RTU Carpet Pump Spray in homes, [garages], [attics], [apartments] and [hotels]. One bottle will treat a surface area equivalent to approximately three 9' X 12' rooms. Avoid wetting furniture and carpeting. A fine spray applied uniformly is all that is necessary to kill fleas.

No need to remove plants from the home while applying product. Do not spray directly on plants. Remove birds, nursing puppies and cats, and cover fish bowls before spraying.

To kill ticks, roaches, ants, spiders, crickets, silverfish, earwigs, and pillbugs; apply directly to pests.

**STORAGE & DISPOSAL:** Store in original container; away from children. Protect from freezing or high temperatures. Do not reuse empty container. Wrap and put in trash.
