One treatment with Zoecon RF-273 Fogger gives continuous protection for **210 days (30 weeks) (7 months)**. Zoecon RF-273 Fogger leaves no bad smell and, used as directed, does not stain furnishings.

For most effective results, entire dwelling should be treated. Use one fogger for each 1500 sq.ft. of floor space (approximately 39' X 39' or twelve 10' X 12' rooms).

1. Close outside doors and windows and turn off fans and air conditioners.
 2. Extinguish open flames including pilot lights.
 3. Remove pets, but be sure to leave pet bedding, as this is a primary hiding place for preadult fleas and must be treated to get best results. No need to discard pet bedding after treatment. It is not necessary to cover or remove fish tanks or bowls.
 4. Remove or cover exposed food, dishes and plastic items such as eye glasses, stereo covers, and notion boxes. Leave rugs, drapes, slip covers, upholstered furniture in place. Used as directed, this product will not harm them, just the preadult fleas hiding inside.
 5. Place fogger on a raised area such as a table or chair with newspapers covering the area directly under the can.
 6. Remove cap, turn cap upside down.
 7. Tilt top away from face.
 8. Place hole in cap bottom over stem on top of can.
 9. Press cap down until firmly in place releasing spray.
 10. Set can in upright position and leave treated area for 30 minutes.
 11. After 30 minutes, open all doors and windows, turn on air conditioners and fans and let the treated area air for 30 minutes. Relight pilot lights.

6. Keeping at arm's length, point top of can away from face and press down actuator tab to lock in position and start fogging action. Set in an upright position and leave treated area for 30 minutes.
 7. After 30 minutes, open all doors and windows, turn on air conditioners and fans, and let the treated area air for 30 minutes. Humans and pets may then use the area without concern. Relight pilot lights.

STORAGE & DISPOSAL: Store in cool area away from children. Do not reuse empty container. Wrap and put in trash collection.
