For Use Indoors

It reaches fleas hidden in carpets, rugs, drapes, upholstery and pet bedding. Protects your home from reinfestation and flea buildup, your pets and family from bites. One treatment gives continuous protection against preadult fleas for 120 days (17 weeks)(4 months).

For Use on Dogs and Cats

ZOECON RF-275 SPRAY (also) kills fleas and ticks on dogs and cats.

To protect your pet against fleas outdoors, use a (brand name) flea or flea and tick collar, (brand name) pet dust, (brand name) pet dip, or (brand name) pet shampoo.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS - CAUTION: May be harmful if swallowed or inhaled. Avoid contact with skin, eyes or clothing. Wash thoroughly after using. For Use Indoors

Fleas and Ticks: Hold can [upside down] 2-3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture. One can will treat a surface area equivalent to approximately three 9' X 12' rooms. Avoid wetting furniture and carpeting. Do not spray wood surfaces as water spotting may occur. A fine mist or spray applied uniformly is all that is necessary to kill fleas and ticks. Re-treat as necessary.

To Kill Roaches, Waterbugs, Silverfish, Crickets, Ants, Centipedes, Sowbugs, and Spiders, apply directly to pests.

For Use In Pet Area

Be sure to treat pet bedding and other resting places as these are primary hiding places for fleas and ticks. No need to remove pet bedding after treatment. Follow directions as for other indoor areas.

For Use On Dogs and Cats

Fleas and Ticks: Spray at a distance of 6-12 inches until the entire coat is damp. Ruffle coat and spray against the lay of the hair for best coverage. Be sure spray wets ticks for best results. Re-treat as necessary.

STORAGE & DISPOSAL:

Store in a cool area away from children. Do not reuse empty container. Wrap and put in trash.
