FOR USE INDOORS

Zoecon RF-275 Spray contains a unique combination of ingredients that [reaches and] kills (both) adult and preadult fleas [hatching larvae] before they grow up to bite. It reaches fleas hidden in carpets, rugs, drapes, upholstery, and pet bedding. Protects your home from reinfestation and flea build-up, your pets and family from [flea] bites. One treatment gives continuous protection against preadult fleas [hatching larvae] for 210 days (30 weeks) (7 months).

FOR USE ON DOGS AND CATS

To protect your pet against fleas outdoors, use a (Brand Name) flea or flea and tick collar, (Brand Name) pet dust, (Brand Name) pet dip, or (Brand Name) pet shampoo.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS - CAUTION: May be harmful if swallowed or inhaled. Avoid contact with skin, eyes, or clothing. Wash thoroughly after using.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Do not use on puppies or kittens under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant, animals on medication, or nursing animals.

When used in commercial food processing, storage, preparation or serving areas, or in the house, all processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Cover exposed food. Do not apply while processing, preparation, or serving is underway. Remove birds and cover fish aquariums before spraying.

FOR USE INDOORS

Fleas and Ticks: Hold can [upside down] 2-3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes, and all surfaces of upholstered furniture. One can will treat a surface area equivalent to approximately three 9' X 12' rooms. Avoid wetting furniture and carpeting. Do not spray wood surfaces as water spotting may occur. A fine mist or spray applied uniformly is all that is necessary to kill fleas and ticks. Re-treat as necessary.

[Other Pests]

To kill roaches, waterbugs, silverfish, crickets, ants, centipedes, sowbugs, and spiders, apply directly to pests.

FOR USE IN PET AREA

Be sure to treat pet bedding and other resting places as these are primary hiding places for fleas and ticks. No need to remove pet bedding after treatment. Follow directions as for other indoor areas.

FOR USE [TO KILL FLEAS AND TICKS] ON DOGS AND CATS

Fleas and Ticks: Spray at a distance of 6-12 inches until the entire coat is damp. Ruffle coat and spray against the lay of the hair for best coverage. [If treating for ticks, for best results, be sure spray wets ticks.] Be sure spray wets ticks for best results. Reapply every 7 months, if necessary.

STORAGE and DISPOSAL: Store in a cool area away from children. Do not reuse empty container. Wrap and put in trash.
