- 4. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with PIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

This product contains GENCORR Insect Growth Regulator, an ingredient which inhibits roaches' natural ability to reproduce, thereby eliminating future generations, and an ingredient that kills existing roaches. This formula reaches roaches through cracks and crevices to kill them where they hide.

One to two weeks after application you will begin to see roaches with crinkled wings showing the effects of GENCOR. These roaches cannot reproduce. Immature roaches are prevented from developing into reproductive adults, thereby effectively breaking the roach life cycle.

Use Zoecon RF-287 Fogger to kill adult roaches and to inhibit roaches natural ability to reproduce future generations. Zoecon RF-287 Fogger should be applied every 4 months to maintain continous protection.

Zoecon RF-287 Fogger is also effective in controlling flea populations. It effectively breaks the flea life cycle by preventing their development into adults.

Zoecon RF-287 Fogger leaves no bad smell, no sticky mess, and used as directed, does not stain furnishings.

- 1. Close outside doors and windows and turn off fans and air conditioners.
- 2. Extinguish open flames, turn off pilot lights in the treatment area.
- 3. Open interior doors and closets of areas to be treated. Open all cupboards and drawers and remove contents.
- 4. Remove pets. Cover or remove fish tanks and bowls.
- 5. Cover or remove exposed food, dishes, utensils, food handling equipment and plasti items such as eye glasses, stereo covers, and notion boxes. All food processing surfaces should be covered during treatment or thoroughly cleaned before using.
- 6. Leave rugs, drapes, slipcovers, and upholstered furniture in place. Used as directed, this product will not harm them.
- 7. Place fogger on floor, table or chair with newspapers covering the area directly under the can.
- Keeping at arm's length, point top of can away from face and press down actuator tab ~ to lock in position and start fogging action. Set in an upright position and leave treated area for 2 hours.
- 9. After 2 hours, open all doors and windows, turn on air conditioners and fans, and let treated area air for 30 minutes. Relight pilot lights.
