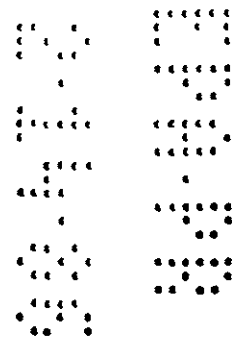

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

The Zoecon RF-293 Methoprene Bolus for Beef and Dairy Cattle when placed in cattle in the spring will provide a sustained release of methoprene sufficient to prevent the emergence of adult horn flies from the manure of treated cattle for 6 1/2 months. Existing adult horn flies will not be affected.

Administer the Zoecon RF-293 Methoprene Bolus orally with a balling gun. Estimate body weights carefully and administer in accordance with the following table.

<u>No. of Boluses</u>	<u>Body Weight</u>
1/2	136 kg (300 lbs) to 299 kg (659 lbs)
1	300 kg (660 lbs) to 640 kg (1400 lbs)

Horn flies will not develop in the manure of nursing calves. It is not necessary to treat calves until they are weaned.

Do not administer to cattle too small to swallow boluses.

Allow sufficient time for the swallowing reflex to occur. Observe animals following dosing to insure that if boluses are regurgitated, the animal involved is re-treated.

STORAGE AND DISPOSAL: Store in cool, dry area. Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Dispose of empty container in a sanitary landfill or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
