1. ALTOSID CP-10 is a light, fluffy product and therefore, whenever possible, the material should be added directly to the mixer. Elevators, long free-fall gravity chutes, etc. should be avoided.
2. It is critical in order to avoid loss of the low density premix that additions be made under conditions of low air turbulence or flow (shut-off exhaust systems during ALTOSID CP-10 addition).
3. Whenever possible, add the ALTOSID CP-10 after the addition of the liquid components and blend to homogeneity.

STORAGE AND DISPOSAL: Store ALTOSID CP-10 in a cool place. Do not contaminate water, food, or feed by storage or disposal.

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.
